Dear Mr. Long:

This refers to previous correspondence and discussions regarding the application of Rules 52 and 57 of the N&W/Wabash and Southern System BMWED Agreements, respectively, as they relate to the establishment of an appropriate rate of pay or differential for employees who operate certain Carrier Material Handling Trucks/Log Loaders that have been upfitted to permit the movement of train cars via a single knuckle on the rear of the vehicle. During our discussions, it was agreed as follows:

Machine Operators who have been assigned to certain upfitted Material Handling Trucks (UMHT)/Log Loaders will receive a rate of pay of \$39.75 per hour. Additionally, a retroactive pay adjustment of \$1,400.00 each will be issued to twenty-five (25) employees to account for the difference in pay (See Attachment A).

Employees not listed in Attachment A will receive compensation upon verification by Supervision and Labor Relations.

Employees who are currently occupying positions where these UMHTs are utilized will remain in the position, provided that they comply with the requirements of the vehicle and successfully complete all required training necessary to move rail cars. If an employee is unable to pass the required training or, upon delivery of the UMHT, chooses not to accept the additional training and responsibilities, they may be released from the position and will have the right to exercise their seniority in accordance with their applicable Collective Bargaining Agreement.
